

# Specific Terms & Conditions: Mega Cash for Vodafone Anniversary Promotion

#### **Description**

The Mega Cash for Vodafone Anniversary Promotion Specific terms and conditions shall apply to Vodafone Mobile Prepaid active subscribers only.

Mega Cash for Vodafone Anniversary Promotion shall be offered from the  $5^{th}$  March 2021 to  $29^{th}$  April 2021.

#### **Terms and Conditions**

# 1. Eligibility

a) Mobile Prepay Customers who are located where the network is available are eligible for the promotion

#### 2. The Offer

- a) Mobile Prepay Customers shall get 1 entry by doing either:
  - i. A refill of 300VT and above;
  - ii. A subscription of an All in WAN plan of 250VT and above;
  - iii. A subscription of WAO Data plan of 400VT and above;
- b) There will be two (2) National Weekly winners for seven (7) weeks, six (6) winners for each of the six Provincial Major prizes, and one (1) winner for the National Grand Prize as per table below:

# 3. Conditions

## A. How to Enter the Draw

- (i) Customers refilling for the amounts of 300vt and above shall get one (1) entry to the draw and a chance to win one (1) of the prizes.
- (a) Customer shall recharge from Refill card and e-Top, and/or M- Vatu.
- (b) Mi2U transfers does not provide entries to the draw.
- (ii) Customers subscribing to any WAO Data plan from 400VT and above shall get one (1) entry to the draw and a chance to win one (1) of the prizes.
- (iii) Customers subscribing to any All in Wan plan from 250VT and above shall get one (1) entry to the draw and a chance to win one (1) of the prizes.

#### B. Draws and Prizes



- (i) There will be 2 National Weekly draws for 2 National Weekly prizes per week for the periods as detailed in the table referred to in Clause 2 (b) herein.
- (ii) Customers that did not win on a National weekly draw will lose their entries for the next National weekly draw but will still have their entries for the Provincial Major Draw and the National Grand Prize draw.
- (iii) For the Provincial Major Prizes, a draw will be carried out from all the entries from each respective Provinces subject to verification whereby the customer will be called to confirm their place of residence. If no answer or they (the Customer) are not from that Province the draw will be continued until a person living in the Province is reached and wins the Provincial Major Prize.
- (iv) The Prizes to win will also be announced in the different Communication Media such as Vodafone's Social Media Page, News Paper, Radio and/or TV.
- (v) Draws will be done in Vodafone shop or any other official Vodafone reseller venue/premises. To ensure transparency and fairness, for the Provincial Major Prize draws and the National Grand Prize draw, a representative from the Regulator's office and the Media may be present to oversee the processes of these draws.

## C. Collection of Prizes

- (i) Customers in Efate, Santo, Malekula and Tanna winning one (1) of the National Weekly Prizes, Provincial Major Prize and/or National grand prize will be contracted and shall receive their Prize in Vodafone Shop of each respective Island, depending on the location of the winner, or through M-Vatu as per their preference, within the period of 14 days after each draw.
- (ii) Customers in Islands other than Efate, Santo, Malekula and Tanna, winning one (1) of the National weekly Prizes, Provincial Major Prize and/or National Grand Prize will be contacted and shall receive their prize in the nearest Vodafone Shop, Vodafone Kiosk or Vodafone Master Dealer, or through M-Vatu as per their preference, within the period of 14 days after the draw.
  - a) A Winner may collect his prize via relatives
  - b) Relative's contact of the Winner shall be provided to Vodafone by the Winner



- c) Winner or Relative will have to present, either, an ID card, Passport, VNPF Card, Driver's license or Birth Certificate and also the SIM card containing the phone numbers of the winner or relative.
- d) If the prize has been stolen or any other inconvenience after the handing over of the prize, Vodafone cannot be held responsible.
- (iii) The Customer must keep in his possession his phone or be able to answer his phone at the time of the call to be claim his prize and avoid any inconvenience.
- (iv) If someone else than the SIM card owner answers Vodafone phone call and claim to be the Winner, Vodafone cannot be held responsible for any inconvenience caused.
- (v) If after the 14 days period, the winner or person appointed, despite the reminder that Vodafone will send, does not collect the prize, it will be void and there will be no other winners.

- a) Vodafone staffs members are not eligible to the promotion and will not enter into any draw described in table above.
- b) Vodafone's visitor pack users are not eligible to promotion and will not enter draw
