Mobile Broadband Postpaid Revamp

Description

The Specific Terms and Conditions of Vodafone 4G plus Mobile Broadband offer(s) shall apply to prospect and existing Vodafone customers. 1. Eligibility

- a) Prospect and existing customers who are located in areas where Vodafone 4G Plus network is available
- b) Vodafone staff who are located in areas where Vodafone 4G plus network is available are also eligible for this offer

2. Offer(s) Description

- a) The offer is accessible over Vodafone 4G plus network
- b) The customer shall be offered a Router device at 50% discount being 6,750VT (vat incl.) per unit. Such discount pricing will be valid from 31st March to 1st May 2020 only. Thereafter the device price will revert to its normal price of 13,500VT. This will not apply to existing Customer already in possession of a Router device.
- c) A Post-paid Sim card shall be offered for free to the customer [unless the customer is an existing customer already in possession of a valid Postpaid SIM Card].
- d) A customer shall choose to subscribe to one of the following Mobile Broadband Postpaid plan(s);
 - a. Life Plus 20GB offering 20GB Data for 5,000 VT plus VAT,
 - b. Family Plus 45GB offering 45GB Data for 10,435 VT plus VAT,
 - c. Business Plus 100GB offering 100GB Data for 20,000 VT plus VAT,
 - d. Business Plus 200GB offering 200GB Data for 29,000 VT plus VAT,
 - e. The customer may be offered extra additional data to purchase as shown in the table below.
 - f. If a customer wishes to top up their main data volume, they may purchase additional Data.
 - g. Additional data is only valid until the billing date



h. Data Volume shall be offered once off only when the customer requested. No renewal shall be allowed.

- i. Customer shall consume data offered in the plan from 6:01AM to 9:59PM and Free internet shall be offered from 10PM to 6:00AM daily
- j. Once data volume in each plan is exceeded, the customer may access internet but at low speed of 128Kbps or 256Kbps
- k. Consumption on *Pay as you go* shall not be allowed
- l. A 12-month contract shall be offered
- e) Access to Free Internet
 - a. With the free unlimited Internet from 10:00PM to 6:00AM, the customer shall be allowed access to free internet and not consume data from the main volume.
 - b. Customer shall only be allowed access to Free Internet if Data is still available.

3. Registration of Service

- a. The customer shall visit a Vodafone shop or consult a Vodafone Sales Agent and request for the service.
- b. The Sales agent shall offer the Router device and a 4G plus Sim Card and provision the customer with the postpaid plan. The postpaid plan shall be automatically renewed each month.

4. Condition of the Offer

- a. Customers who are located in Areas where Vodafone 4G plus network is available shall be eligible for the offer.

- g. Customers must comply with Vodafone's standard payment term which is payment on or before the 20th of each month
