

Specific Terms & Conditions: My Vodafone Pack

Description

The Specific Terms and Conditions apply to all VODAFONE customers and prospects, subject to the Condition set out below.

The My Vodafone Device Pack Promotion shall commence on the 7th of March 2020 and ending on the 30th of April 2020. Vodafone may use this promotion any time after the 30th of April 2020. Customers subscribing to the service agree to the following Specific Terms and Conditions regarding the appropriate plan(s).

Terms and Conditions

1. Eligibility

- a) Vodafone Customers and Vodafone prospects are eligible for this promotion
- b) Vodafone staffs are eligible for the promotion

2. The Offer

- a) A customer or prospect wishing to benefit from this promotion shall be offered:
 - i. [(4,200 Minutes On-Net Calls + 6GB + Unlimited SMS) over 12 Months] when purchasing one (1) Alcatel 1
 - Customers purchasing this package shall pay upfront amount of 6,900VT, which is the special price of the Alcatel 1, and shall be offered 350 Minutes On-Net Calls, 500MB and Unlimited SMS for a period of 12 months totaling up to 4,200 Minutes On-Net Calls, 6GB and Unlimited SMS.

Unlimited SMS for a period of 12 months totaling up to 12,000 Minutes On-Net Calls, 18GB and Unlimited SMS.

- iv. [(12,000 Minutes On-Net Cals + 18GB + Unlimited SMS) over 12 Months] when purchasing one (1) Smartphone of 15,000VT and Above.
 - Customers purchasing this package shall pay upfront amount of the smartphone (≥ 15,000VT) and shall be offered 1,000 Minutes On-Net Calls, 1.5GB and Unlimited SMS for a period of 12 months totaling up to 12,000 Minutes On-Net Calls, 18GB and Unlimited SMS.
- b) The Volume of On-Net Calls, Data and SMS shall be provisioned automatically to the eligible customer GSM number every month for 12 Months.
- c) The Volume of On-Net Calls, Data and SMS shall be valid 15 Days.
